**Guidelines for Eligibility**

Psych Testing and Court Order Drug and Alcohol services are not eligible for rate discount on the sliding fee scale  
 Financial Assistance Application must be completed and submitted to be eligible for discounts on the sliding fee scale.  
 Only residents of Crawford County will be eligible to receive a discount on the sliding fee scale.
